

## JERRY ROBINSON 1920 - 2014

**Editor's note:**

*Dad wrote a weekly column for most of his long newspaper career. Here is reprint of one he wrote about a favorite topic, fishing, from 1962.*

The other day my housekeeper, Paulette Joy Lovely, (honest, that is her real name) was at Lincoln park in West Seattle and was astounded by the huge number of fisher folk on the shoreline fishing for salmon. Men, boys, women, grampas, grammas, all lined up with casting rods attempting to bring home fresh caught Pink Salmon or whatever else might be swimming by.

Most were using spinning rods and casting colored spoons while standing on the bank though there were also a bunch of boats cruising out of reach of the

shoreline anglers. She counted 70 people on the bank thrashing the saltwater to a froth. She even spotted an eagle cruising overhead watching for dinner and took a picture of it. Paulette Joy Lovely has a son who is a fishing guide on the Columbia River near Vancouver, where she has caught huge steelhead when floating with him. She's very helpful to me too. I'm hooked.

Fishing was my passion early on. Once I took Jim Willis, the manager of the famous (now long since closed) Epicure restaurant, in White Center, to Campbell River Resort in Canada. He was not an avid angler like me but he wanted to go. Jim was a slightly built man and well dressed. I don't think he owned a pair of boots but he could have used them instead of those pretty oxfords he was wearing.

We trekked out to find a good spot, not far from the lodge. I was using a fly rod and he just wanted to stand near the bank of the famous river.

While he watched, I waded out to the middle of the turbulent stream and almost instantly hooked a giant King Salmon. Lots of salmon there get over fifty pounds and mine bent my fly rod into a big U and took off downstream heading for saltwater. I moved to more shallow water and went after him.

Jim moved up to the narrow road behind me and followed the battle with bugged out eyes and those shiny shoes. He was not too happy watching and

running to avoid losing sight of me. He yelled to me. "It's almost FOUR", somehow believing I should just stop fishing and head back to the lodge with him. I think he was praying the monster fish would come unbuttoned because he kept yelling at me to cut the line. He had not come to fish. He had come to eat.

I did not know this. He managed a restaurant for a living and was always around food. He might have had a tapeworm. He was praying the line would break or the huge fish would come loose. Jim's hunger superseded his interest in me catching this fish. I wanted to land the monster and have people at the lodge rave about what a great angler I was.

Fishing is a wonderful sport. It often takes a while to land the big ones. After about an hour, the great fish was not as tired as I. I never even caught a glimpse. By this time Jim was so anxious he was preparing to cut tree bark for a meal so I just cut the line and clambered out to the road. It might have been a derby winner. Jim was happy. He led the way down the road to the resort and the restaurant. He did not even clean his dancing shoes as he sat down at the dining table.

I had been skunked before. You get over it. Just the same, I kinda wished I had known what it weighed.

## Herbold: One Center City update and potential West Seattle impacts

District 1 Seattle City Councilmember Lisa Herbold has outlined changes coming to downtown transportation in her constituent newsletter, and points out potential impacts on commuters from West Seattle and Burien as a variety of planned changes are implemented.

“Since late 2016, the One Center City working group has been meeting to coordinate management of a high volume of changes coming to Downtown transportation between 2017 and 2019. The working group includes SDOT, Sound Transit, King County Metro, and the Downtown Seattle Association. Different government agencies would implement elements of the proposal.

Upcoming projects in that time frame include the removal of the Alaskan Way Viaduct and opening of the SR 99 tunnel; the closure of the Downtown Transit Tunnel to buses with the arrival of light rail to Northgate, Lynnwood and the Eastside; the re-opening of Alaskan Way; a 1st Avenue Streetcar; a Bus Rapid Transit line on Madison; and the proposed Convention Center expansion.

On June 8 One Center City released a “Proposed Near-term Projects” plan. While most of the proposals affect Downtown, some of the projects could impact West Seattle bus access to Downtown.

The proposal includes potential changes to rush-hour only Routes 37, 56 and 57

in the Alki, Admiral and Alaska Junction neighborhoods, as well as to buses from White Center and Burien (see map at right), by re-routing buses to go by the Pioneer Square Light Rail Station on 3rd Avenue, then proceed eastbound to First Hill.

King County Metro will begin a public engagement about these potential service revisions beginning in July.

A second potential impact on West Seattle service would be during 2019, when the Alaskan Way Viaduct is closed. Buses such as the C Line that currently access Downtown via the Alaskan Way Viaduct will access Downtown by Alaskan Way when it reopens in 2020. However, this leaves a gap of around a year where buses will need to be re-routed. In my discussions with SDOT and King County Metro, 1st Avenue and 4th Avenue have been mentioned as potential options, but there isn't a specific proposal yet.

A potential concern is regarding the construction of the 1st Avenue Streetcar project. SDOT is planning to phase work in conjunction with Viaduct removal, though it will need to be well managed to avoid any delays; any work on 1st Avenue must be completed or paused if West Seattle bus routes such as the C Line are re-routed onto 1st Avenue during 2019-2020.”

## WSTC light rail workshop sought feedback locations, routes and more

The West Seattle Transportation Coalition (WSTC) hosted a community-led workshop Thursday evening so the public could offer its thoughts about future light rail plans.

“Light rail at its core is part of an integrated transportation system,” said Tom Linde, one of the community organizers at the beginning of the meeting. “Luckily, even with limitations, our problems aren’t unique. They have been solved already by our joining neighborhoods.”

Around 50 people attended the event.

Councilmember Lisa Herbold was in attendance. Light rail is to be completed in West Seattle by 2030.

The crowd was shown a powerpoint presentation, which generally explored how trains work. There are three types of train modes engineers can choose from: build rail on flat ground, above ground or below ground. Flat is the least expensive option, and the fastest to build, but obstacles include hills and water. The light rail stretch on Rainier Ave S. is an example of rails installed on flat topography. Above ground or elevated rail is the second-least

expensive option, and second-fastest to build. However, it doesn’t work as well on hilly terrain and leaves a larger footprint. An example is Angle Lake Station. The beauty of below ground rail or subway is it can be installed under busy urban cities with minimal interference to property owners and pedestrians. However, it is two to four times more expensive than other modes, and it takes longer to build. An example of subway is UW Station.

Questions were taken from audience members. Then the event delved right into the breakout session, where attendees could provide feedback on six potential light rail sites or issues:

1. Delridge Station Area
2. Avalon/35th Ave. S.W. Station Area
3. Junction Station Area
4. WS Route Maps and Bird’s Eye View
5. The “Kitchen Sink”
6. Anything else

WSTC will assemble the results into a formal document and present it to Sound Transit, the King County and Seattle City Councils, the Seattle Department of Transportation and local stakeholders. As this will be West Seattle’s first ST3 design review process, the WSTC will urge Sound Transit to combine West Seattle’s preferred routing options with ST3 overall plans.

## Quick action by Starbucks employee saves a man's life

### Customer collapses on the sidewalk

An adult male suffered a catastrophic medical emergency just prior to making entrance to the Starbucks located in the 14800 block of Ambaum Blvd. S.W. According to witnesses who called 911 just before 5 p.m., the gentleman experienced a sudden cardiac event, went unconscious and collapsed on the sidewalk at the entrance to the store. According to the American Heart Association (AHA) out of the 350,000 out-of-hospital cardiac arrest events occurring annually, 90% die because they don't receive immediate CPR from someone on scene. Remarkably, it has been reported that CPR performed in the first few minutes, can double or triple the chance of survival. This was

the case in this event. Due to the fast actions of Natasha Stapp, a Starbucks employee performing citizen CPR, the chain of survival went unbroken. In addition, quick arrival and professional performance by Burien firefighters, King County Medic-One Paramedics and Tri-Med Ambulance employees, the Burien community member was resuscitated and transported to Highline hospital where he was reportedly discharged within days with no deficits. This incident is a great example of the highest level of community involvement, reflecting great individual credit upon the Starbucks employee and the professional services involved in saving the life of the community member we all proudly serve.

## Three candidates run for Des Moines City Council Position 5

Election day is August 1, and Des Moines City Council Positions 1 and 5 are on the ballot.

Councilmember Melissa Musser currently holds Position 5.

"I recognize that it is time for me to step aside and allow someone else to step up, someone with thicker skin and a fresh perspective," Musser said within her letter announcing that she would not be seeking another term.

Three local candidates are running for election for Position Five: Traci Buxton, Patricio Mendoza and Harry Steinmetz.

Musser is endorsing Steinmetz - she suggested initially that he run for office.

"In addition to his stellar resume of qual-

ifications, Harry is a genuinely good guy, even if he does have a fondness for puns," Musser wrote.

Steinmetz has lived in Des Moines for 18 years, and has extensive experience in county and state government.

He has worked for the King County Prosecutor's office, was a city prosecutor for Olympia, an investigative officer for the Washington State Commission for Judicial Conduct and a staff attorney for the Washington State Senate Judiciary Committee. He became the director of government relations for the Washington Association for Housing and Services for the Aging, where he advocated on behalf

## Golden Gardens heats up, brings crowds and advice from SPD

When the warm summer air rolls out across the Sound, through the sails and trees at Shilshole Bay, and as the Solstice sun heats the sand at Golden Gardens Park, people from all nooks of the city throng the beach there for a day under the rays. At nightfall, the some 13 fire pits bloom up from the darkness in blazing ornaments amid the dark sand dunes.

It's no wonder that with the flux of thousands of bodies on the beach, there will be some uncouth characters wobbling the disc of the eternal plane. Large groups can spark en masse conflagration, consternation and agitation—but mostly at the park there have been issues with theft, underage drinking and assault.

Over the past three years the Ballard

News-Tribune has documented numerous cases of property damage, theft, underage “partying” and assault at the park. The dog park just up the hill from the beach has long-time been an area recognized as a hotbed for car prowling.

“Golden Gardens starts to heat up on Memorial Day and lasts through the summer until school starts again. SDP monitors the entire park. We will walk the entire beach area including the upper parking areas. We monitor the dog park as well and will get crowds that park there and travel to the beach area down the stairs,” said Sgt. Lori Aagard with SPD.

Sgt. Aagard took time to answer BNT questions before working what the department calls the “Golden Gardens Emphasis,” last Friday night.

Moreover, one assault incident last year left one man temporarily blinded. There have also been assaults involving gangs. More recently, a sex offender attacked a woman in the Golden Gardens park restroom. Luckily she was able to fend off her attacker.

Still, beyond all cases, the major issue SPD faces are minors consuming alcohol in the park.

“In the past we have had crime increase in the park. If we show a presence early in the summer this kind of activity is not likely to occur. The main problem we deal with is the alcohol consumption and the things that occur around excessive and underage drinking. We will get large juvenile parties on the beach with amplified music, alcohol and illegal campfires. Every week we usually have to call SFD for juveniles who have consumed

too much alcohol.”

But SPD has plans to mitigate minors consuming illegally.

“SPD responds to this by assigning a Friday and Saturday night Golden Gardens Emphasis Squad. Starting Memorial Day Weekend, a squad of 5 officers and 1 sergeant is assigned as an overtime emphasis shift that focuses on Golden Gardens. We walk the entire beach and have the beach goers put out their illegal fires and require them to put away any alcohol that they may have. We warn and educate early in the night to avoid problems later. We make PA announcements to the crowds regarding rules, parking and lock the park up at 11:30 p.m. A high, early police presence deters crime and safety issues later in the evening. We want the beach

## The voice of the Storm has Mt. Rainier High roots

**D**ick Fain competed in two sports at once in his days at Mount Rainier High School in Des Moines.

He swam and played basketball during the winter of his freshman, sophomore and junior years before a rule change forced him to decide between the two for his senior year.

He opted for basketball...

Now he is working three jobs at once, all in the realm of broadcast journalism.

His main gig is as the host of the 5:30 a.m. sports show on KJR-Radio, and he also serves as a sports anchor for KING-TV.

But he is best known as the voice of the Seattle Storm professional Women's National Basketball Association team for its home telecasts on JOEtv.

"It makes for a long day, especially when I sports anchor at KING-5 at 3 p.m. and my last TV hit is at 11:25 at night, only six hours before I go on the radio," said the 43-year-old 1992 graduate of Mount Rainier. "Then the summer is busy with the Storm doing play-by-play on TV for them at KeyArena. But when you enjoy the job you don't worry about the weird schedule or a lot of hours."

Fain certainly enjoys his jobs after getting his start in "broadcasting" at a very young age.

"I've always wanted to get into broadcasting since I was a kid," he said. "I started when I was like five or six years old. I was running around calling Sonics games and Mariners games, you name it."

Fain focused on competing himself in high school during the winter season.

"My junior year we won a state cham-

pionship in swimming," Fain said. "And I was part of a medley relay team that won."

He also played basketball.

"But then they made a rule that you couldn't play multiple sports in the same season," he said. "I had a choice to make. The swim coach said I could be team captain my senior year, but I chose basketball.

With the state championship I had accomplished what I wanted in swimming, but not in basketball."

After graduating, Fain studied broadcast journalism at the University of Washington while it still had the program.

"I think I shut down the school," said Fain, who graduated from the UW in 1996.

Fain coached summer swimming for 10 years, but he also served 15 years as the head boys basketball coach back at Mount Rainier High School.

"Had I not played basketball, I probably would not have gotten that job," said Fain.

He held that position until five years ago.

"I'm just coaching my son now," said Fain, who lives in Normandy Park with his wife Janna of 10 years, 7-year-old son Dixon and 5-year-old daughter Aubrey.

His broadcasting career also blossomed quickly.

"I did a couple of internships at KIRO-TV and KIRO-Radio," Fain said. "I worked on the morning show with Jeff Aaron. I called him when I got out of college and asked if any jobs were open."

That led to the KJR job.

of not-for-profit senior housing and long-term care providers.

Steinmetz also has his own law practice in Tacoma.

"I've been through the legal process, so I understand how that works," Steinmetz said.

Steinmetz lives in the Woodmont neighborhood with his family, and points out that the council is missing representation from the Zenith, Woodmont or Redondo communities in southern Des Moines.

Steinmetz's platform deals largely with boosting the economy in Des Moines by developing the downtown area and the marina in order to create sustainable revenue for the city.

"I think the community needs better leadership on the council and better forms of developing the community along with the marina," Steinmetz said.

Steinmetz wants a steady property tax, "so we're not getting people out of Des Moines," Steinmetz said.

Buxton grew up in Tacoma, and has lived in Des Moines for 35 years.

She has had experience in over 10 dif-

ferent arenas of business: property management, real estate, investment, office administration, insurance, mental health, community service, online sales, fitness, contracting and hospitality.

"It's a good time in my life to move from being a complainer to being a solver," Buxton said.

Preventing crime is one of the principal elements in Buxton's platform.

She wants more resources to address human trafficking issues along the Pacific Highway South corridor from a multi-city standpoint, which would include the municipalities of Des Moines, Tukwila, SeaTac, Kent and Federal Way.

"It's one of the highest trafficking spots in the country and it runs right through our backyard," Buxton said.

Buxton's other focuses include the environment and economic productivity.

"Des Moines has some issues," Buxton said. "I think I could be a good component in the leadership to solving those issues."

Mendoza immigrated to the United States from Chile in 1991, and currently lives in the Zenith neighborhood of Des Moines. He is active in the community through volunteer work and is a board member of 4Cul-

ture and a member of the Des Moines Rotary Club. He has operated EC Computers, a small business on Marine View Drive in downtown Des Moines—for 23 years.

"I'm the only one running to have a business on the main street in downtown Des Moines," Mendoza said. "I do everything in Des Moines."

Mendoza's platform engages with three challenges facing Des Moines: bringing more businesses to Des Moines, lowering the crime rate and implementing policies which benefit the environment.

Mendoza said that making Des Moines more business-oriented will add to the City's revenue so it can hire a larger police force and in turn, decrease crime in the city.

"We need to enhance our economic development so we can provide the essential services our people deserve," Mendoza said in a statement on his website.

Like Buxton, Mendoza wants to establish cooperation between multiple area cities to lower crime rates in Des Moines.

Mendoza also wants to partner with the Port of Seattle to work on progressive environmental policies and to ensure fair treatment for community members who have been impacted by the airport.

goers to enjoy the beach and stay safe."

Seattle Police Department knows what the summer heat wakes up in the general population, and as crowds swarm in June, SPD bumps their patrols through the park. Still, SPD officers cannot be at the park all the time, especially when the North Precinct, headed by Captain Sean O'Donnell, covers the largest sector in Seattle, an area that spans from Sand Point to Golden Gardens Park and serving 25 communities which include, Aurora, Ballard, Bitter Lake, Broadview, Carkeek, Crown Hill, Fremont, Green Lake, Greenwood, Lake City, Laurelhurst, Licton Springs, Loyal Heights, Maple Leaf, Northgate, Phinney Ridge, Ravenna Bryant, Roosevelt, Sand Point, Sunset Hill, University District, View Ridge, Wallingford, Wedgwood.

Areas that heat up in the summer on the

North end include Magnuson Park, and nightlife areas in Fremont, Ballard and the University District. So when officers aren't there they have basic safety and crime prevention tips for visitors and beachgoers.

"For safety, I would make sure that you leave nothing in your parked car. Car prowlers will break into a vehicle just to see what may be in a bag or back pack. Even if there is nothing of value in the bag or backpack, you now have a broken window to deal with not to mention the personal violation. When you go to the beach always be aware of what is going on around you and report any suspicious activity to 911 or to our patrols who will present there to handle any situations. We have a high presence at the beach and lots of contact with the beach goers. If there is any issues we are easy to find."

Other tips include:

- Pay attention to your instincts; if something doesn't feel right

- Be aware of your surroundings. Keep your eyes up and not on your phone.
- Walk with purpose and project an assertive and business-like image. Criminals will be discouraged if you do not appear vulnerable or easily intimidated.
- If alone after dark, use a ride service such as Lyft, Uber or a cab.
- Walk in well-lit areas; Use main streets and avoid shortcuts through dark areas.
- Learn to carry your purse or wallet safely. Purses should be closed, held in front of your body, with your arm across it. Wallets should be carried in a front pants pocket or in an interior jacket pocket. If you see anything suspicious call 911.

Facial features of the suspect were difficult to identify in the video. The victim plans to transfer the footage onto a disk and give it to officers to place into evidence.

Around 6 p.m. on Sun., June 18, police received reports from a couple on the 1800 block of Harbor Avenue S.W. The woman explained they had been paddle boarding, when they saw an older white boat coming

towards them. The woman started waving at the boat, because she thought it was going to hit her. She said the driver continued to approach her and then would turn around, again and again, which was terrifying to her. The driver was laughing. The male victim was scared for the woman's safety. As they were leaving, the man approached the boater who was in a silver Toyota truck. The driver stuck his hand out the window and made a motion of pulling a trigger. The couple walked away and called 911, reporting the license plate number of the truck.

### NEW UPDATES TO THE CASE OF "THE CREATOR"

The suspect in an assault on Sun., June 13, who later died as a result of the altercation, has been identified as 20-year-old Tommy Le.

Le lived around the corner from the house where he was identified by neighbors as being aggressive—and later shot by police.

Detectives served a search warrant on this house, where knives were recovered. Officers are trying to ascertain if one of the weapons was used in the original assault.

Officers had arrived in the 13600 block of 3rd Avenue S. just before midnight on Sun., June 13, after receiving multiple calls regarding shots being fired. Callers described the suspect as shouting, "I am the Creator" and "I am the killer," as he tried to stab people. There were 10 patrol units dispatched to the area.

Three deputies in separate vehicles arrived first, Deputy Cesar Molina, Deputy Matt Paul, and Deputy Tanner Owens. Sev-

eral individuals were in the front yard of a house and on the street waiting.

One homeowner said a friend came to his door, yelling that someone was chasing him with a knife. He armed himself with a handgun and went outside. While standing in front of his house, the homeowner was confronted by a man holding a knife or sharp object. The suspect advanced in a threatening manner, and the homeowner fired a round into the ground as a warning. The suspect, however, continued to move forward.

The homeowner ran back into his house and slammed the door, just as the suspect was about to enter. The suspect began pounding on the door and stabbing it with the object he was holding, while screaming out that he was "the Creator."

As deputies were listening to the story, one of the victims pointed out the suspect, who was about a half block away and walking down the street towards the officers.

Owens and Molina confronted him and told him to drop whatever was in his hand. The suspect kept advancing as the deputies backed away and circled around the man, who was making stabbing motions.

The deputies fired their Tasers at the suspect, who only continued to advance. Detectives are still unsure why the Taser had no effect.

Deputy Molina fired several times, and the man was hit and fell to the ground.

The object the suspect had in his hand at the time of the shooting was a pen.

Deputies immediately began lifesaving first aid efforts and also called for the fire department and medics to respond. The suspect was then transported to Harborview, where he died of his injuries.

"I've spent 20 years total at KJR," Fain said. "I got the morning show."

Fain's stay with the Storm started with their inception in 2000.

"I started with the radio broadcast," he said. "I did stats and some reporting. Then I worked my way into play-by-play and if the color guy was gone then I'd step into that role. I started in 2008 as play-by-play and spent 2008-2013 on radio. Then I went from radio to TV. I do all of the home games on TV. I don't travel with the team anymore."

While on radio, Fain got to call the

Storm's championship game in 2010.

"I did play-by-play for that," Fain said. "I was around in 2004 for the first championship, but being able to call the play-by-play in the final seconds of one of Seattle's few championships was great."

Fain remembers it well.

"When we were ahead with one or two minutes left, I thought 'Oh my gosh, they're actually going to do this,'" he said. "I was thinking 'This is your chance to call a championship, don't screw it up.' But I caught a break. Atlanta came back and just needed three to tie it with a few seconds left. Then the nervousness left. Then I was just able to call the action. I was just call-

ing the action instead of worrying about what to say when the Storm won the title."

Fain sees more bright days ahead for the Storm.

"We kind of got out of a three-year rebuilding phase," he said. "Like they say, in basketball you got to win the (draft) lottery. We got No. 1 picks Sue Bird and Lauren Jackson, and they're two Hall of Fame-type players who won two championships. Hopefully it will be the same with Jewel Lloyd and Breanna Stewart. You have two potential all-star players for years to come. The chances are very good they'll win another championship in the not too distant future."



The Deputy involved in the shooting, who has been with the King County Sheriff's Office for more than two years, was placed on administrative leave.

The number of times the suspect was hit will come from the Medical Examiner's Office. The number of shots fired is part of the on-going investigation by the Sheriff's Office Major Crimes Unit.

The completed investigation will be sent to the Prosecutor's Office to determine if criminal charges are warranted. The shooting will be reviewed administratively by the sheriff's Office Administrative review Team. The Sheriff's Office will conduct a Use of Force Review Board, and the Office of Law Enforcement Oversight will review all administrative actions taken by the Sheriff's Office.

Sheriff Urquhart will forward the case and all reviews, including the results if the inquest, to the FBI for federal review.

## Woodland Park Zoo says new baby giraffe is a girl

The Woodland Park Zoo announced last week that a neonatal exam revealed the new baby giraffe born June 20 is a female.

The calf was born to first-time mother, Tufani, 8, and like her mother, she's tall standing at 5 feet 9 inches and weighing 149 pounds.

A viable giraffe calf has not been birthed at the zoo since 2013, and the calf was born to parents, Tufani and 4-year-old Dave.

Tufani and the calf have been moved to an isolated barn setting for quiet maternal bonding and nursing. Testing shows that Tufani is passing along nutrient and anti-body rich colostrum and that the calf is nursing normally. Tufani's antibodies prevent the calf from getting sick until she can produce her own, according to Dr. Darin Collins, Woodland Park Zoo Director of Animal Health.

"The first 24 to 72 hours are critical for giraffe

calves, but so far she seems to be doing well," said Collins.

"She's a very mobile calf," explained Martin Ramirez, mammal curator at the zoo. "She's showing early signs of curiosity and adventure. Eventually, she will begin to follow her mom to the outdoor corral where zoo-goers could possibly catch a glimpse of her. But expect sporadic viewing since she can choose to go off view in the barn."

Currently, the calf and mother are off view in the barn to allow a quiet environment for maternal bonding and nursing. It will be at least a few months before the calf is introduced to the African Savanna exhibit.

Tufani and the calf will be in the nursing barn for the next few weeks. The Zoo announced that the zoo's giraffe cam, which will allow the public to view the calf and mother, can be accessed at [zoo.org/tallestbaby](http://zoo.org/tallestbaby).






### THE WHIMSICAL WORLD OF BJØRN WIINBLAD







## A ferry story for adults

There was a low tide at noon that Friday in May—minus 1.5 feet, as I recall.

Anxious to reach my weekend retreat on Lummi Island, I had driven past Bellingham to Gooseberry Point. From there I planned to take the Whatcom Chief, the small county ferry that travels once an hour to the island.

I pulled into line at the ferry dock, where I could count 20 cars ahead of me—almost at capacity for the tiny Chief.

With the tide so far out, the ferry bobbed, low in the water, its landing ramp perilous-

ly close to perpendicular. The line of cars moved ahead and it looked like I might make that run, perhaps the last car to board.

I finally reached the top of the steel ramp and inched ahead, only to have the gate suddenly swing down, crashing onto the hood of my car. It hit with jarring impact.

Just then, the ferry worker looked up and saw my predicament. It was obvious he had closed the gate prematurely, unable to spot my car. When he realized his error, he raised the gate and waved me forward.

After I pulled in, the worker stood by my window apologizing. He said that, with the water so low and the ramp so steep, he had simply failed to see my car. By then the ferry was pulling out of the slip and my passenger and I were on deck examining my car hood. We could see several parallel scrapes, perhaps a dozen.

The worker, a pleasant young man, took pictures of the damage, recorded my name and license number. He gave me a printed sheet with details on how to file a claim.

Rats. A hassle ahead, I thought. The sheet directed me to call Whatcom County Public Works to request a claim form. Instructions said I must fill in the form and attach pictures of the damage along with two repair estimates.

Come Monday, I called the county and quickly received an emailed claim form. What I needed now were two estimates.

Four days later I was seated in the office of a North End auto body shop, explaining the freak accident and asking for an estimate. The very professional adjuster examined the damage and came back with a detailed estimate: \$1,106.87, an amount that including wet sanding, buffing, primer, corrosion protection and tint, with the possibility of an increased amount for blending into fenders. The job would take two days.

My second trip was to a nearby repair shop, a busy place where I waited some time for an adjuster. After hearing my story, he gave me an itemized estimate of \$698.91.

That included labor, paint, supplies and a charge for "hazardous waste disposal."

The two estimates—\$400 apart—left me perplexed. Given such a large gap, I decided to seek yet another bid.

My uneasiness took me to a third repair shop, this one on a busy street in Seattle's University District.

It was late afternoon as I entered the office and encountered three men handling the phones. I said I needed an estimate for some damage caused by an accident at a ferry landing.

"Do you have an appointment?" asked

one annoyed-looking fellow. I admitted I didn't, but pleaded that the website said they were open until 5 p.m. More exasperation.

I was preparing to leave when a worker appeared from within and asked to look at the car which I had parked out front. He peered at the scratches and returned with a yellow greasy paste and a small hand tool. Without a by-your-leave, he bent over the hood and began to work intently.

I thought he was still assessing the damage. But, within 10-15 minutes, he turned to me and said in a faint but clipped English accent, "Do you see any damage?"

I looked over the car's hood and had to admit that it seemed good as new—maybe better since the car had been dusty when I brought it in.

"That's amazing," I said. "Please give me the bill," I added, fingering my purse.

"No bill," he protested. I tried to insist but he was adamant: "There is no charge."

I thanked him—couldn't thank him enough. Not only did I have a repaired car, but a great story to tell and a future recommendation. For anyone who asks: get three estimates; one may be \$0.

## The right play

Did you happen to watch the Tony Awards on TV a couple of weeks ago? It's Broadway's version of the Oscars—except instead of awards going to movies you haven't seen, they go to plays you haven't seen.

But on this particular Tony night, bunches of awards went to at least one play that perhaps you have seen—or at least heard of. That's because while the movie industry has "remakes"—and television has "re-runs"—the theater business has "revivals."

One of the big ones this season is a musical from the 1960's called Hello, Dolly! It's loaded with tunes including one called Hello, Dolly! (Hope I didn't just ruin the play if you've not yet seen it. Here's a further ruination of a famous play: In Death of a Salesman—a salesman dies.)

As I watched the Tony broadcast—and the cast and producers of the legendary Hello, Dolly! took their bows—not one of them referred to the play as having saved a life. But that's probably because they didn't have the same experience with it that I did. (I'll get back to that 'saving a life' thing shortly.)

I became familiar with the songs in Hello, Dolly! because I performed a couple of them a few years ago on an actual stage—when the Fifth Avenue Theatre made the risky—and some say misguided—decision to cast me as the male lead, Horace Vandergelder.

The opportunity to be in a big musical at a major theater was too wonderful to pass up, but I was scared to death. What if I was lousy? I could already hear the reviews:

"I loved my seat in the back of the theater. I could barely hear Cashman's singing from there."

"The play began great. Then Cashman entered."

"Two things in Hello, Dolly! should be cut: The second act...and Cashman's throat."

Still, I decided that if a Seattle audience did throw fruits and vegetables at me, at least they would be locally grown and organic.

In the weeks leading up to the first rehearsals, I got loads of advice. Perhaps the most helpful was: "If you accidentally fall off the stage into the orchestra pit—try to aim for the kettledrum. It sounds the funniest."

But with my luck, I figured it would more likely be the tuba—and they'd need the 'Jaws of Life' to get me back out.

Nervous as I was—with first rehearsals looming—my wife came up with an idea that seemed perfectly wrong. "Let's go on a cruise for a week," she said. "I found a great deal to Mexico."

"No can do," I said ungrammatically. "What could possibly be a reason for going on a cruise when I've got lines and lyrics to learn? Plus, my memory is so bad I can't even remember what I ate last night."

"It was garlic fries," she said, holding her nose. "And if you agree to go with me, I'll

help you rehearse your lines every day of the cruise, so that by the time we return, you'll know all of them."

It made sense. She told me so. And that decision is how a life was saved. (Told you I'd get back to that.)

True to her word, as we rose each morning, she would drill me on dialogue as punishingly as a sergeant. "It's Hello, Dolly," she'd scold. "Not Hey, What's Up, Dolly?" Slowly but surely I started getting it down—all the words, the inflections, the songs.

On the final morning of the cruise, I told her we could skip the rehearsing. I was ready. But she insisted we run through the entire play one more time. I put my foot down. She put her fist up. And that's why we stayed put in our room 45 minutes longer than I wanted.

Just as we finally finished the line reading—and were about to go up on deck—I heard what sounded like crying coming from the direction of the small balcony off our room. I leaned around the partition between our cabin and the adjoining one—and saw a woman—weeping bitterly—leaning out over the railing. She was—more than apparently—thinking about jumping the nine stories into the ocean below.

While my wife gently spoke with her, I ran out into the hall and alerted the ship's security folks. They arrived in time to enter her room, sneak in—and pull her down from the railing.

Whether that woman would have actually leapt is unknown—but here's hoping that these years later, she's hale, hearty—and happy that she didn't.

Later that final cruise day—as we departed the ship—my wife turned to me and said, "Good thing we went on this cruise, wasn't it?"

I looked at her admiringly and said, "Wonderful woman!" It seemed like the perfect description of the person I married.

It was also my final line in Hello, Dolly! Pat did not 'break a leg' during the play—
