Contrary to RCW 9A.44.050(1)(a), and against the peace and dignity of the State of Washington.

PROSECUTING ATTORNEY CASE SUMMARY AND REQUEST FOR BAIL AND/OR
CONDITIONS OF RELEASE

The State incorporates by reference the Certification for Determination of Probable Cause prepared by Detective Narottam D. Holden of the Seattle Police Department for case number 2021-26419.

Given the random act of physical sexual violence in this case, the State requests this Court set bail in the amount of \$75,000.00, the amount imposed at the defendant's first appearance in King County District Court. CrR 2.2.

In this case, the defendant attacked the victim, a complete stranger, who was merely at a public stop. The defendant physically assaulted and sexually violated the victim before the victim was able to break free from the defendant. Unfortunately, the defendant pursued the victim before forcibly raping her in a public space. The victim immediately reported this horrific assault and fortunately Seattle Police were able to quickly apprehend the defendant.

The facts of this case demonstrate the eminent danger this defendant poses to our community at-large and the high risk that the defendant will commit future acts of sexual violence if released on less restrictive alternatives to incarceration or lesser bail amount.

The defendant has a previous conviction for Theft in the Third Degree from 2012.

That *Narottam Holden 8322* is a *Police Officer* with the *Seattle Police Department* and is familiar with the investigation conducted in *Seattle Police Department 2021-026419*. There is probable cause to believe that *HUSSEIN, MAHDI M, 3/2/1993* committed the crime(s) of:

- *Rape In The Second Degree (Forcible Compulsion)*, in *SEATTLE*

County of King, in the State of Washington.

This belief is predicated on the following facts and circumstances:

Certification for Determination of Probable Cause

That Narottam Holden is a Detective with the Seattle Police Department and has reviewed the investigation conducted in Seattle Police Department Case number 2021-026419 There is probable cause to believe that Hussein, Mahdi M. DOB: 03/02/1993 committed the crime of RCW 9A.44.050 Rape in the second degree within the City of Seattle, County of King, State of Washington. This belief is predicated on the following facts and circumstances.

On February 1, 2021 at approximately 0303 hours Seattle Police Department patrol officers responded to California Ave. SW and SW Alaska St. regarding a sexual assault. At approximately 0345 hours I, Detective N. Holden, and Detective R. Christensen were contacted about this incident. We responded to Harborview Medical Center and conducted a recorded interview with victim O.H. (DOB: 08/12/1999). O.H. is biologically a female who has transitioned to male and prefers the pronouns he/they. For the purpose of this report the victim will be referred as O.H.

On the above date in the early morning hours (time unknown) Victim O.H. was sitting on a bench at King County Metro bus stop at the intersection of California Ave. SW and SW Alaska St. when adult male suspect Mahdi Hussein approached the O.H. and sat right next to O.H.

Hussein began telling O.H., "you're my queen". Hussein then placed his hand on O.H.'s inner thigh. O.H. demanded Hussein stop then faced away from him. While still sitting on the bench Hussein reached around O.H., hugged O.H. from behind, and placed his hand inside of O.H. pants and underwear. Hussein then penetrated O.H.'s vagina with his fingers. O.H. pushed Hussein off and began to walk away from Hussein heading westbound on Alaska St. SW. Hussein got up from the bus stop and followed O.H. O.H. pleaded for Hussein to stop.

Hussein was able to catch up to O.H. and, "bear hugged" O.H. from behind trapping O.H.'s arms. Hussein then tried to force O.H. into a nearby alley but was unable to do so. Hussein got in front of O.H. and grabbed O.H.'s breast with his hands on top of O.H.'s clothing. O.H. was able to get around Hussein and began running westbound on Alaska St. SW in attempt to get away from Hussein. O.H. eventually made it to a park where Hussein caught up to O.H. and forced O.H. against a railing. Hussein then pulled his pants down and began pushing his penis against O.H.'s buttocks on top of O.H.'s clothing. O.H. was able to duck between the railing and get away from Hussein.

O.H. turned around and headed back towards the bus stop however, Hussein continued to pursue O.H. Hussein again caught up to O.H. and was able to force O.H. against a brick wall in a nearby alley way. While using his bodyweight Hussein held the front of O.H.'s body against the brick wall. Hussein pulled his and O.H.'s pants down and proceeded to forcibly penetrate O.H.'s anus with his penis. This continued for a few seconds then Hussein suddenly stopped for an unknown reason. O.H. was unsure if Hussein ejaculated. When Hussein stopped O.H. was able to again get away from Hussein and continued back to the bus stop. Hussein now followed a little behind O.H. and O.H. was able to covertly dial 911.

Hussein asked O.H. if O.H. was calling the police. O.H. then made it to in front of a Starbucks which is located at 6501 California Ave. SW. and moments later police arrived. When officers arrived O.H. positively identified Hussein as the suspect. Hussein was placed into custody and later transported to the Seattle Police Department Headquarters and placed in interview room #664.

After interviewing O.H. Detective Christensen and I responded to the Seattle Police Department Headquarters to interview Hussein. This interview was recorded. I read Hussein his Miranda rights and he verbally acknowledged them. Hussein then requested a lawyer and the interview was terminated.
