

16	That the defendant JULIUS T BOOTH in King County, Washington, on or about
17	December 30, 2020, with intent to inflict extreme mental distress on Jorden L. Gayton-Roybal, did intentionally abduct Jorden L. Gayton-Roybal, a human being;
18	Contrary to RCW 9A.40.020(1)(d), and against the peace and dignity of the State of
19	Washington.
20	And further do accuse the defendant, Julius T Booth, at said time of committing the above crime against an intimate partner as defined in RCW 26.50.010(7), which is a crime of
21	domestic violence as defined in RCW 10.99.020.

5 6	The State incorporates by reference the Certification for Determination of Probable Cause prepared by Deputy Patrick Kelly of the King County Sheriff's Office for case number C20041540.				
7	I, Angela J. Kaake, Senior Deputy Prosecuting Attorney, declare that I have reviewed the				
8	Certification, discovery, and defendant's criminal history; I further declare that the victim's first name is spelled Jorden on the Renton Municipal No Contact Order, which was issued as a post-conviction criminal order on November 24, 2020. In addition, the other child in the vehicle is the				
9	defendant's and Ms Gayton-Roybal's child in common, L.B-T. DOB 4/23/2020.				
10	The defendant recently pled guilty to Assault 4 DV in Renton Municipal Case 9Z0529166 with Jorden Gayton-Roybal as the victim. He was sentenced on November 24, 2020, and according to				
11	the docket was released from custody that same day. This incident occurred less than one month after his release from SCORE jail.

13	Under penalty of perjury of the laws of the State of Washington, I, Angela J. Kaake, Senior Deputy Prosecuting Attorney, certify that the foregoing is true and correct. Signed and dated by me this 31st day of December, 2020.

17	The State requests bail in the amount of \$750,000 and a no contact order between the				
18	defendant and victim, as well as the defendant and the two minor children who were present in				
19	the car during the crimes. The defendant's actions in this case are extreme. His violence,				
20	kidnapping, and flight from police endangered many lives throughout King County, not the least				
21	of which was his own infant child. He committed these crimes in violation of a domestic				
22	violence no contact order issued by the city of Renton for the protection of the victim. The State

is charging the aggravating factor for rapid criminal recidivism as well as the reckless endangerment of the children.

The defendant also has a history of unreported domestic violence with the current victim. She reported to police prior incidents of assault, including strangulation, threats and verbal abuse. She indicated that his behavior is getting worse in frequency and future assaults are likely to recur.

Of note, in a different Renton Municipal case, the defendant also recently pled guilty to two counts of Reckless Endangerment DV with a different intimate partner victim and a different minor child. In that case, the child was also in the car, without a car seat, when the defendant also fled from police and endangered the child and the community. The defendant pleaded guilty to those offenses and was sentenced to jail at SCORE. As a result of the defendant's behavior no contact orders were put in place with that victim and the child. The victim also sought a civil domestic violence protection order against the defendant in October of 2020 for her protection and that of her minor child. In that petition under Court Case Number 20-2-14589-1 the victim was granted a temporary protection order detailing abuse by the defendant, prior reports to police agencies, and that the defendant also assaulted her relative. The temporary order was denied in November as on October 29 as neither party appeared—the petitioner spoke Spanish and was not contacted through the Superior Court virtual waiting system.

The defendant also was also involved in a Seattle Police domestic violence incident report with yet a different victim in 2019 which involved her being thrown out of his car. That victim did not cooperate with the investigation and charges were not filed. An excerpt from that case:

Certification for Determination of Probable Cause

That *Patrick Kelly 94460* is a *Deputy* with the *King County Sheriff's Office* and is familiar with the investigation conducted in *King County Sheriff's Office C20041540*. There is probable cause to believe that *Booth, Julius T*, *5/28/1986* committed the crime(s) of:

- Investigation Attempt to Elude; and
- · Investigation Kidnapping; and
- Investigation Violation of Protection Order/No-contact Order

County of King, in the State of Washington.

This belief is predicated on the following facts and circumstances:

On 12/30/2020 at approximately 1548 hours, Sqt Hamill traveled southbound on Military RD S approaching S 200th St in an undercover detective vehicle. Sqt Hamill was slowed down and came to a stop in traffic waiting for the traffic light at S 200th St. He noticed a silver Suzuki SUV license plate WA/BKM4273 parked on the west side of Military RD S. A female later identified as Jordan L Gayton-Roybal date of birth 07/31/1997 was standing outside the Suzuki visibly upset. Jordan was slapping the passenger side window yelling at the car. Sgt Hamill rolled down his window and could hear Jordan hitting the car window, yelling, "give me my baby, give me my baby." Later identified as Julius T Booth, a male, date of birth 05/28/1986, exited the driver's seat of the vehicle, walking toward the passenger side of the car. Julius started yelling at Jordan to get into the car. Sgt Hamill watched as Julius started forcefully pushing Jordan towards the open passenger door of the vehicle. Julius forced Jordan up against the open passenger door. After Julius managed to get Jordan in the car, he walked back to the driver's side. Jordan attempted to climb across the front seat to get into the driver's seat of the vehicle as Julius got into and pushed her back to the passenger seat. Sgt Hamill could not see any children in the car but based on Jordan's actions and emotional actions, he believed children were inside the vehicle. After seeing Jordan forced into the car and her efforts to get into the driver's seat in a blatant attempt to prevent Julius from getting in the car. Sgt Hamill believed he was witnessing a kidnapping. Jordan resisted getting in the vehicle, and from Sgt Hamill's observations of Julius forcefully pushing Jordan in the car. Jordan made a blatant attempt to get into the driver's seat to drive the vehicle away or prevent Julius from entering the car. Sgt Hamill broadcasted the information to King County radio and requested marked units. Julius started the car and drove it onto southbound I-5, as Sgt Hamill followed him directing marked patrol units to stop the vehicle. Sgt's Mulligan and Graf were the first two units to reach the vehicle as it passed S 272nd ST on highway I-5. Once Mulligan and Graf were behind Julius in the Suzuki, they activated their emergency lights and sirens to conduct a traffic stop on the vehicle. Julius immediately took evasive action by accelerating and passing cars in the roadway as traffic increased approaching the Highway 18 interchange. Julius continued his evasive actions by conducting a u-turn on I-5 at the emergency turnout between I-5 north and I-5 south. Julius was driving on the left with speeds in excess of 80 MPH. As they approached S 320th St in heavy traffic, Julius cut across all lanes of I-5, exiting at S 320th St, heading eastbound. Sgt's Mulligan and Graf slowed down to safely exit and continue the pursuit with Julius. They temporarily lost sight of Julius while they attempted to safely exit S 320th and enter the roadway without causing any accidents. Julius continued driving southbound on Military RD S from S 320th ST, weaving in and out of traffic at speeds upwards of 70 plus miles an hour, putting driver and pedestrians at serious death or grave bodily injury risks. Julius continued driving recklessly at an excessively high rate of speed on Military Rd S until he reached SR 161 and started traveling northbound, weaving in and out of traffic at high rates of speed, endangering other drivers and pedestrians. Julius continued on SR 161 to 16th Ave S, passing S 348th St, where he turned northbound onto Pac Hwy. At the intersection of S 336th St, one Police officer attempted to deploy spikes stripes to disable Julius's vehicle and safely end the pursuit. Julius drove towards the police vehicle, exited the roadway into a parking lot to avoid the spike strips, and continued driving on the sidewalk to avoid the spike strip. Julius continued his evasive maneuvers turning eastbound onto S 325th St, northbound on 17th Ave S, eastbound again onto S 324th St with speeds in excess of 60 mph in heavy vehicle traffic. Julius continued to S 320th St. He internally drove on the sidewalk in an area with a pedestrian foot track and heavy vehicle traffic because of the entrances and exits for I-5 north and south. Julius continued his reckless driving at a high rate of speed as he entered I-5 northbound from S 320th St. Deputies and Officers attempted to give Julius space to slow and stop the pursuit, but he continued traveling at speeds more than 80 to 90 mph. As the pursuit continued northbound on I-5, Deputies gave a space ranging from 1/2 to 3/4 of a mile as King County Sheriff's helicopter Guardian One called the pursuit. Julius continued weaving his way in and out of trafficking at a high rate of speed till he exited I-5

at S 188th St in SeaTac; Julius headed westbound on S 188th St headed northbound on Military RD S where he lost control of the vehicle swerving all over the road almost hitting multiple cars in traffic. Julius continued northbound on Military RD S, swerving in and out of traffic, endangering other drivers and pedestrians on the sidewalks. Julius headed westbound on S 176th ST, weaving in and out of traffic, failing to stop at multiple traffic lights and stops in residential neighbors where kids play, and people walk. Julius turned northbound onto International Blvd, which has heavy traffic at this time of the day. At S 170th St, where there was heavy traffic since the airport entrance is to the west, Julius started driving on the sidewalk where we always have significant pedestrian traffic due to the multiple hotels, gas stations, and restaurants. He continued northbound on International Blvd to S 154th St, where he turned westbound. Julius entered highway 518 towards Burien and exited onto northbound on 1st Ave S. When Julius turned onto 1st Ave S, he lost control of the vehicle. In his efforts to regain control, Julius had to slow down. This gave deputies an opportunity to conduct a PIT maneuvered. This maneuver effected ended the pursuit, and Julius was taken into custody without incident. Due to the quick actions of the deputies conducting the PIT maneuver no one in the vehicle was injured and no civilians were injured.

Sgt's, detectives, and Deputies learned that a signed, served Domestic Violence Protection Order was in place after Julius was placed under arrest. Julius was the respondent, and Jordan was a protected person.

Detective Grotzky and I interviewed Julius at SeaTac City Hall. Detective Grotzky read Julius his Miranda rights from the suspect statement form. Julius gave us permission to record the interview, and he told us he understood his rights when asked. The only thing Julius would tell us was that he knew the police were behind him trying to stop him. Julius told us he was scared of the police, and that's why he did not stop. After that, Julius asked for an attorney, and the interview was ended.

Detective Grotzky and I conducted a recorded interview with Jordan's permission. Jordan told us the following. "Gayton-Roybal said she and Booth had been fighting all day. They pulled into a gas station off of 272nd Street after her older daughter, identified as A R (DOB 03/19/16) puked on herself. Gayton-Roybal said she had asked Booth to move the car so another car could pass by and Booth moved the car to the other side of the property which upset her. They ended up getting back into the car and left. Gayton-Roybal said they continued to argue till Booth made a comment similar to he would piss on her grave as they were approaching the stop light at S. 200th St at Military Rd S. Gayton-Roybal started yelling at Booth that she wanted the kids out of the car because she did not want to be around him. She added she knew he had an order against her. Once they stopped at the red she decided to get out of the SUV to get away. Gayton-Roybal said she started tugging on the back door to get the kids out, but Booth was reaching back, holding the lock to keep her from opening the back door. Gayton-Roybal said she started banging on the back window. As this was going on, Booth got out and came round to Gayton-Roybal, told her to get back in the car while grabbing her, and then pushing her into the car. Gayton-Roybal said she had her cell phone, but at one point Booth took it from her and she could not remember if he had taken it from her in the vehicle or once she was outside. Gayton-Roybal thought her phone was now under the driver's side seat of the SUV. Gayton-Roybal told us it did not cause her any pain being shoved into the car.

I asked Gayton-Roybal if she was tying to get away? Gayton-Roybal at first said I don't know if I was trying to get away, or if I was more just mad at what was going on and trying to get away from him , just trying to get away from arguing, not having to deal with it." Gayton-Roybal clarified that she was trying to get her kids out of the car and, "just separate so it didn't turn into something like this." I asked Gayton-Roybal if she felt like she could have walked away if she wanted to? Gayton-Roybal said she thought she could have walked away but her kids were in the car so she did not have the choice to walk away.

Once being pushed back into the car, Gayton-Roybal said the left southbound on I-5 where she thinks someone called the incident in. She said while driving she observed the cop cars approaching them. Gayton-Roybal told me Booth started yelling , "I kept telling him stop the car" and "This is not going to end good, were gonna hurt somebody." I asked Gayton-Roybal if she could see the police cars behind them and if they could see their lights or hear their sirens? Gayton-Roybal told me she could see them but could not hear the sirens. When asked was it clear if it seemed the police were trying to stop them she said, "of course, yes." Later in the interview, Gayton-Roybal said she was yelling at Booth to stop, that someone was going to get hurt, and to stop running red lights.

I asked Gayton-Roybal how her kids were reacting during the police chase. Gayton-Roybal said her 4 Agents was scared. When asked if Agents was crying the whole time, Gayton-Roybal said not the whole time, but at one point fold her mother everything was going to be okay. When I asked about Gayton-Roybal's living situation she told me they have been living in her car since August and also staying at different friend's residences. Gayton-Roybal told me she has been with Booth for approximately 2 years now and Booth is the father of one of the two children."

One of our domestic violence supplemental form questions is about firearms, and if you've been threatened. Jordan told me the last time he was arrested by Renton PD when he came to her work at Walmart; He said to her if he had a gun he would have end it right there. Jordan said she took that as he would have killed her if he had a gun. Jordan expressed her fear of Julius when he gets angry. She had no choice when being pushed into that car by him. She was afraid for both her children's welfare and could not walk away, leaving them with him. Especially since one of the children was not his.

During this entire pursuit, Julius ran multiple red lights in areas of heavy vehicle traffic. Inside the car was his sevenmonth-old baby in a car seat, his girlfriend Jordan's four-year-old daughter from another relationship, and Jordan in the front seat. Julius's actions showed a willful disregard for Jordan's lives, the two small babies in the back seat, and the civilian popular traveling the public roadways on 12/30/2020.
