

# 2025 Q4 King County Quarterly Shots Fired Report



## Total Reported Shots Fired Incidents and Shooting Victims


The number of shooting homicide victims, non-fatal shooting victims, and total shots fired in King County for Q4 2025 are listed below. This data was reported to the King County Prosecuting Attorney's Office by the following King County police agencies: Auburn, Bellevue, Des Moines, Federal Way, Kent, Kirkland, King County Sheriff's Office, Renton, Seattle, Tukwila, and Washington State Patrol. This data does not include suicides or officer involved shootings. Individuals shot in confirmed self-defense cases and confirmed self-inflicted shootings are not counted toward the total fatal and non-fatal victim count.


## Shooting Victim Demographics

Of the 39 shooting victims in Q4, 38% were identified as White, 31% were identified as Black or African American, 90% were identified as male, and a majority of victims were between the ages of 30-39. Compared to Q4 of 2024, there was a **55% decrease in the overall number of shooting victims** and for the first time in Q4 of the last 5 years, Black or African American males did not represent a majority of shooting victims.

### Shooting Victim Age Range Q4 2025





## Number and Type of Shots Fired Incidents Q4 2021-2025


OffenseType ● Shots Fired ● Shots Homicide ● Shots Injury ● Shots Property




Q4 of 2025 saw the lowest number of all types of shots fired incidents since prior to Q4 of 2021, with *shots fired, shots injury, and shots property* incident numbers all experiencing more than a 55% decrease from their peak Q4 numbers.

*Overall* shots fired incidents in Q4 of 2025 (201) decreased from Q4 of last year (372) by 46% and were the lowest they have been since Q4 of 2018. Compared to Q4 of 2023, there was 50% decrease in *overall* shots fired incidents.

## Total Number of Shots Fired Incidents Q4 2021-2025




## Number of Shooting Victims Q4 2021-2025




Mirroring the drastic decrease seen in the total number of shots fired incidents, the number of *shots injury* victims in Q4 of 2025 reached a low that has not been seen in the last eight years. The number of *shots injury* victims in Q4 of 2025 experienced a **decrease of 73%** from its peak Q4 number in 2021 while the number of *shots homicide* victims experienced a slight decrease compared to Q4 of the last few years.

## Total Shots Fired Incidents by Area Q4 2025



In Q4 of 2025, 58% of overall shots fired incidents took place in the Seattle area and 36% occurred in south King County. While south King County had surpassed the Seattle area for total shots fired incidents in Q4 of 2021 through 2024, Q4 of 2025 was the first time Seattle had more Q4 incidents. However, both areas have experienced a consistent decline of incidents compared to Q4 of the last few years, with south King County experiencing a 66% decrease since its peak Q4 number in 2022 and reaching a low that has not been seen in Q4 of the last eight years.





## Number of Shooting Victims 2025




## Shooting Victim Demographics

Of the 235 shooting victims in 2025, 75% suffered non-fatal injuries and approximately half of shooting victims were between the ages of 18-24 and 30-39. While there was more than a 50% drop in the number of Black or African American shooting victims in Q4 to a number that has not been seen in *any* of the quarters of the previous eight years, Black or African American males have remained to be the majority of shooting victims.



## Number and Type of Shots Fired Incidents 2019-2025


OffenseType ● Shots Fired ● Shots Homicide ● Shots Injury ● Shots Property ● Total Incidents Per Year




## Yearly Comparison

Overall shots fired and shooting victim numbers have steadily decreased over the last few years, with 2025 marking the lowest number of shooting victims since pre-pandemic years and the overall shots fired incidents reaching close to pre-pandemic numbers.

While the total number of juvenile shooting victims peaked in 2024 despite the total number of shooting victims not peaking at that time, 2025 saw a 61% decrease in the number of juvenile shooting victims from 2024 and marked the lowest number seen since pre-pandemic years.
