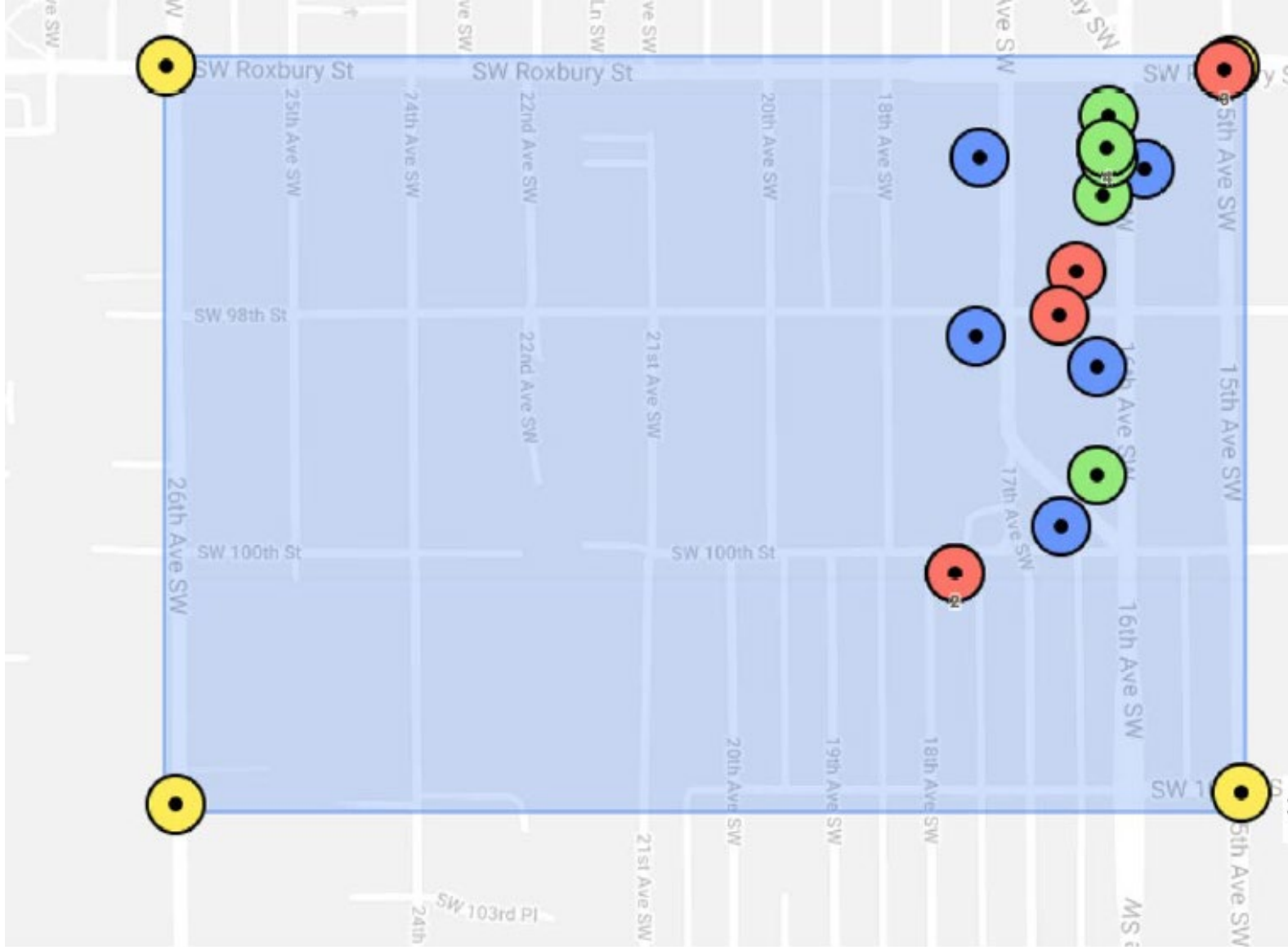

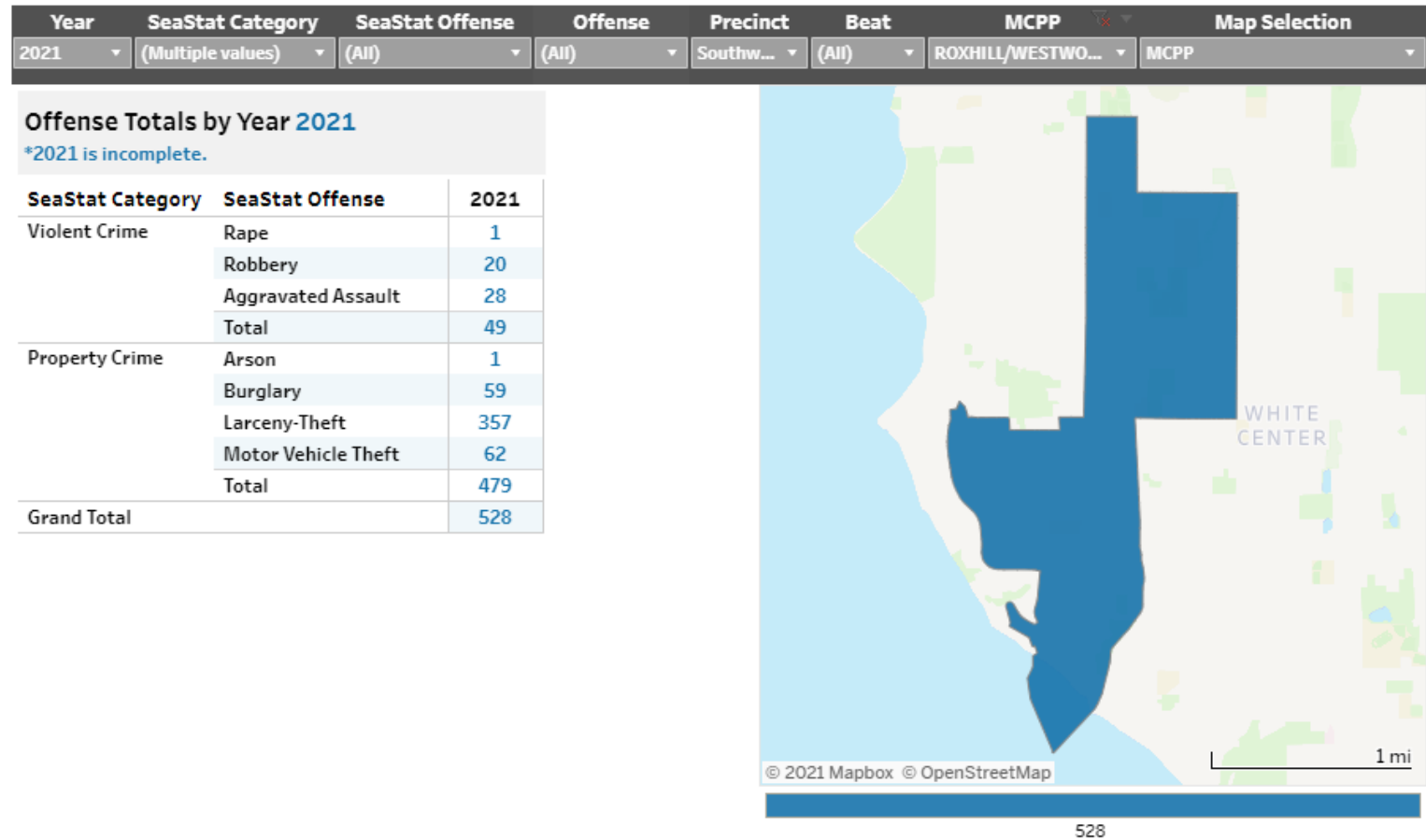

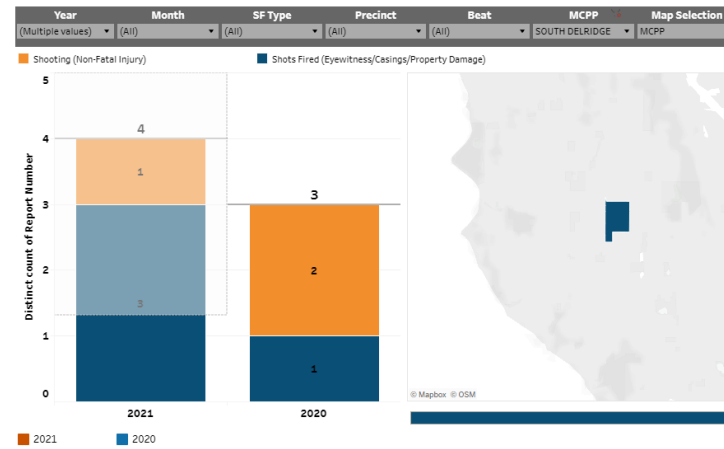

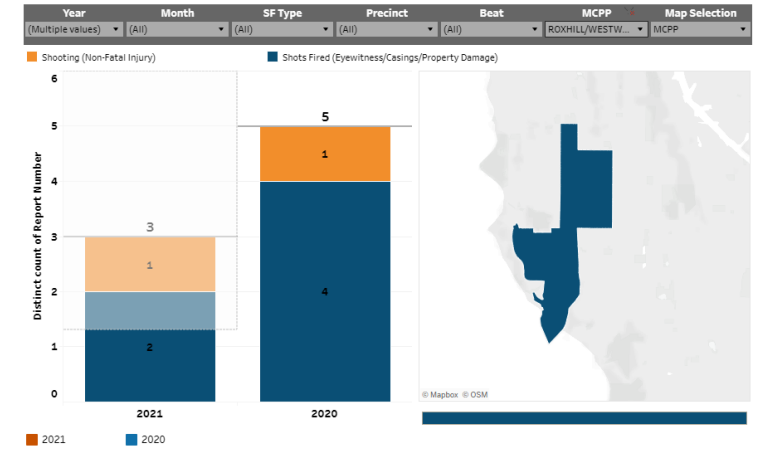

# Fire prevention

- Schedule appointments to resolve/fix any outstanding safety or HVAC systems maintenance issues with an authorized servicing company. (IFC 901.8/IFC 903.5/907.8)
- Store materials susceptible to spontaneous combustion and other flammable materials properly and in an approved container/dumpster and store incompatible materials separately, away from combustible walls, openings, or roof eaves. (IFC 304.3.3/IFC 304.3.4)
- Combustible waste material or vegetation capable of being ignited should not accumulate on premises. (IFC 304.1)

# Fire prevention, continued

- Be sure to keep hallways, stairwells, access, and exits clear and accessible to ensure quick and easy entry for the fire department and egress for occupants. (IFC 1010)
- Label and maintain electrical system components while using extension cords appropriately and no more than 90 days; also be sure that computers have power strips. (IFC 605)
- Test exit signs and directional and emergency lighting. (IFC 1008.2/IFC 1008.3)
- Provide and maintain fire extinguisher(s) and that they are hung correctly, located in plain view or identified with a sign that makes locating them easy. (IFC 906.7/IFC906.5/IFC 906.6)

# Fire prevention, continued

- Maintain all sprinkler heads and protective caps; as well as establish access to the fire department connection, provide the required distance from storage space, and schedule regular maintenance. (IFC903.5/IFC 901.6/IFC 315.3.1)
- Install and service all smoke/CO2 detectors to ensure that they are in working order. (IFC 907.8.5)

# Permitting Division

- Provide building, fire, site reviews, inspections, and code enforcement services
- Following a fire incident, Permitting conduct initial safety inspections and post structures with notices of safe or unsafe to occupy
- Provide expedited permitting services for those displaced due to fire incidences
- Investigate complaints or findings of alleged code violations
- Take appropriate and necessary code enforcement actions with tenant/owner to achieve compliance

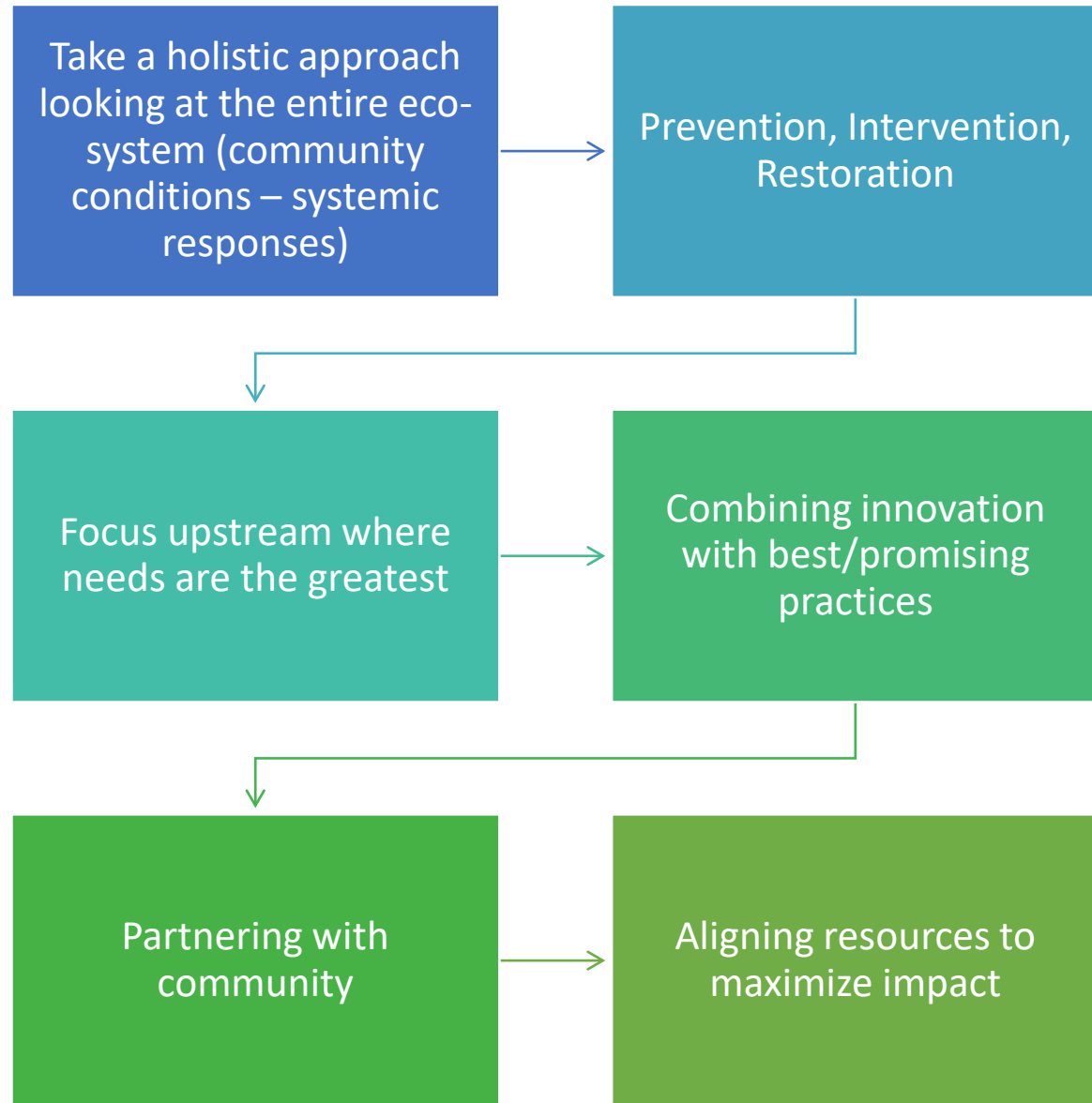


# Public Safety through the lens of Criminal Justice
